The Board of Claims received 71 new claims during the month of April, 2009. A total of 76 new claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed 2 claims for being under the \$100.00 threshold.

Investigators Jackie Lynch and Wanda Luttrell decided 81 claims (under \$1000.00) in April, 2009. Thirty four (34) claims were dismissed and 47 claims were awarded, for a total amount awarded of \$17,887.11.

At its Board meeting on April 16, 2009, the Board dismissed 18 claims and awarded seven (7) claims totaling \$208,816.86. Together with the claims investigated in-house, the Board dismissed a total of 52 claims and awarded a total of 54 claims for a total amount awarded of \$226,703.97 in April, 2009.
