# Board of Claims Agenda

May 16, 2013

The Board of Claims received 55 new claims during the month of April, 2013. A total of 59 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned six (6) claims for lack of jurisdiction.

Investigator Jackie Lynch decided 28 claims under \$1,000.00 in April, 2013. Jackie reports that 21 of these claims were denied and seven (7) were awarded, for a total amount awarded of \$2,208.67.

At its Board meeting on April 18, 2013, the Board dismissed 16 claims and awarded seven (7) claims totaling \$9,107.48. Together with the claims investigated in-house, the Board dismissed a total of 44 claims and awarded a total of 14 claims for a total amount awarded of \$11,316.15 in April, 2013.
