The Kentucky Claims Commission received 42 negligence claims filed against the Commonwealth during the month of April, 2017. Paula reports that 20 claims were set up and one (1) claim was returned for lack of jurisdiction.

Investigator Angela Robertson decided 23 claims under \$1,000.00 in April, 2017. Angela reports that seven (7) of these claims were dismissed and 16 were awarded, for a total amount awarded of \$6,689.68.

At its meeting on April 25, 2017, the Kentucky Claims Commission dismissed five (5) negligence claims and awarded 12 negligence claims totaling \$36,151.98. Together with the claims investigated in-house, the Claims Commission dismissed a total of 12 negligence claims and awarded a total of 28 negligence claims for a total amount awarded of \$42,841.66 in April, 2017.
