## I. OCTOBER MONTHLY REPORT

During the month of October 2024, the Board of Claims received **89** negligence claims filed against the Commonwealth.

The Board rendered 8 decisions in claims *under \$2,500.00* in October 2024. Of those, 4 were dismissed and 4 were awarded for a total amount awarded of \$4,645.01.

At its October meeting, the Board overruled 1 motion and assigned the claim to a hearing officer, and dismissed 5 claims upon motions, Recommended Orders, and *sua sponte* dismissals. With the claims under \$2,500.00, and those decided at the October Meeting, the Board decided 13 claims, dismissing a total of 9 claims, and awarding a total of 4 claims for a total amount awarded of \$4,645.01.
