he Board adopted the minutes of the August 21, 2008 meeting as submitted by the Clerk of the Board.

Executive Director's Report:

The Board of Claims received 79 new claims during the month of August, 2008. A total of 60 new claims were set up, according to Assistant Clerk Paula Woolums.

nvestigators Jackie Lynch and Wanda Luttrell decided 68 claims (under \$1000.00) in August. The Board awarded eight (8) claims for a total of \$166,955.74 at its August 21, 2008 meeting. Seventeen (17) claims were dismissed by he Board at that meeting. Combined with the claims decided in-house, the Board dismissed 57 claims and awarded 16 claims for a total amount of \$178,004.73 in August, 2008.

The Board of Claims received 79 new claims during the month of September, 2008. A total of 63 new claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed four (4) claims for being under the \$100.00 hreshold.

nvestigators Jackie Lynch and Wanda Luttrell decided 54 claims (under \$1000.00) in September, 2008. They lismissed 28 claims and awarded 26 claims for a total amount paid of \$8,435.24 for September, 2008.

The Board did not meet in September due to a lack of a quorum.
