# COMMONWEALTH OF KENTUCKY **Board of Claims** Agenda

The Board of Claims received 47 new claims during the month of September, 2013. A total of 44 claims were set up, according to Assistant Clerk Paula Woolums. Paula also reports that five (5) claims were dismissed for lack of jurisdiction.

Investigator Jackie Lynch decided 31 claims under \$1,000.00 in September, 2013. Jackie reports that 16 of these claims were denied and 15 were awarded, for a total amount awarded of \$7,004.77.

At its Board meeting on September 19, 2013, the Board dismissed 16 claims and awarded 12 claims totaling \$41,324.07. Together with the claims investigated in-house, the Board dismissed a total of 32 claims and awarded a total of 27 claims for a total amount awarded of \$48,328.84 in September, 2013.
