

Menutes approve

The Board of Claims received 46 new claims during the month of September, 2016. Paula reports that a total of 48 claims were set up and two (2) were returned for lack of jurisdiction.

Investigator Angela Robertson decided 26 claims under \$1,000.00 in September, 2016. Angela reports that 17 of these claims were dismissed and nine (9) were awarded, for a total amount awarded of \$2,282.05.

At its last meeting on September 27, 2016, the Board of Claims dismissed eight (8) claims and awarded six (6) claims totaling \$7,461.89. Together with the claims investigated in-house, the Board dismissed a total of 25 claims and awarded a total of 15 claims for a total amount awarded of \$9,743.94 at its last meeting in September, 2016.
