COMMONWEALTH OF KENTUCKY Claims Commission Agenda October 24, 2017



The Kentucky Claims Commission received 61 negligence claims filed against the Commonwealth during the month of September, 2017. Sasha Petrey reports that 39 claims were set up, 10 claims were returned for lack of jurisdiction, and seven (7) claims were dismissed for failure to perfect.

Investigator Angela Robertson decided 10 (ten) claims under \$2,500.00 in September, 2017. Angela reports that five (5) of these claims were denied and five (5) were awarded, for a total amount awarded of \$3,418.57.

At its meeting on September 29, 2017, the Kentucky Claims Commission dismissed two (2) negligence claims and awarded seven (7) negligence claims totaling \$18,189.11. Together with the claims investigated in-house, the Claims Commission dismissed a total of seven (7) negligence claims and awarded a total of 12 negligence claims for a total amount awarded of **\$21,607.68** in September, 2017.
