#### **I. SEPTEMBER MONTHLY REPORT**

During the month of September 2024, the Board of Claims received **68** negligence claims filed against the Commonwealth.

The Board rendered **66** decisions in claims *under \$2,500.00* in September 2024. Of those, **23** were dismissed and **43** were awarded for a total amount awarded of **\$22,892.51**.

At its September meeting, the Board affirmed **1** claim upon Full Board Review, placed **1** claim in abeyance, dismissed **14** claims upon motions, recommended orders, or *sua sponte* dismissals, and entered **6** Agreed Orders of Dismissal, awarding an additional **\$6,250.00**. With the claims under \$2,500.00, and those decided at the August Meeting, the Board decided **87** claims, dismissing a total of **38** claims, and awarding a total of **49** claims for a total amount awarded of **\$29,142.51**.
