I. SEPTEMBER MONTHLY REPORT

During the month of September 2025, the Board of Claims received **96** negligence claims filed against the Commonwealth. The Board rendered **167** decisions in claims *under \$2,500.00* in September, 2025. Of those, **75** were dismissed and **92** were awarded for a total amount awarded of **\$53,757.26**.

At its September meeting, the Board affirmed **5** claims and vacated **1** claim upon Full Board Review, placed **1** claim in abeyance upon motion, dismissed **17** claims via Motions to Dismiss, Recommended Orders, Agreed Orders, and *sua sponte* dismissals, and awarded **5** claims through Recommended Orders and Agreed Orders of Dismissal, awarding an additional amount of **\$20,200.00**. With the claims *under \$2,500.00*, and those decided at the September Meeting, the Board decided **194** claims, dismissing a total of **97** claims, and awarding a total of **97** claims for a total amount awarded of **\$73,957.26**.
