The Board of Claims received 44 new claims during the month of August, 2014. A total of 34 claims were set up and two (2) claims were returned for lack of jurisdiction.

Investigator Jackie Lynch decided 46 claims under \$1,000.00 in August, 2014. Jackie reports that 23 of these claims were denied and 23 were awarded, for a total amount awarded of \$9,952.09.

At its Board meeting on August 26, 2014, the Board dismissed 22 claims and awarded eight (8) claims totaling \$27,328.68. Together with the claims investigated in-house, the Board dismissed a total of 45 claims and awarded a total of 31 claims for a total amount awarded of \$37,280.77 in August, 2014.
