# COMMONWEALTH OF KENTUCKY Claims Commission Agenda

September 24, 2019

The Kentucky Claims Commission received **77** negligence claims filed against the Commonwealth during the month of August, 2019.

The Claims Commission processed and/or decided **74** claims under \$2,500.00 in May, 2019. 37 of these claims were dismissed and 37 were awarded, for a total amount awarded of **\$26,352.54**.

At its meeting on August 27, 2019, the Kentucky Claims Commission dismissed two (2) negligence claims and awarded two (2) negligence claims totaling **\$4,326.00**. Together with the claims investigated in-house, the Claims Commission dismissed a total of 39 negligence claims and awarded a total of 39 negligence claims for a total amount awarded of **\$30,678.54** in August, 2019.
