August 2020 Monthly Report:

During the month of August, 2020, the Kentucky Claims Commission received **42** negligence claims filed against the Commonwealth.

The Claims Commission decided **41** *claims under \$2,500.00* in August, 2020. Of those, **12** were dismissed and **29** were awarded for a total amount awarded of **\$17,755.32**.

At its meeting on August 25, 2020, the Commission awarded **1** additional negligence claim in the total award amount of **\$500.00** and dismissed **2** other claims. Together with the claims investigated in-house, the Commission decided **44** claims altogether while dismissing a total of **14** negligence claims and awarding a total of **30** negligence claims for a total amount awarded of **\$18,255.32** in August, 2020.
