I. JULY AND AUGUST MONTHLY REPORTS

During the month of July, the Board of Claims received 105 negligence claims filed against the Commonwealth.

The Board rendered 111 decisions in claims *under \$2,500.00* in July 2025. Of those, 46 were dismissed and 61 were awarded for a total amount awarded of \$35,367.63.

At its July meeting, the Board affirmed 1 claim upon Full Board Review, granted 1 motion, overruled 2 motions, passed 1 claim to the September Agenda, placed 1 claim in abeyance, dismissed 3 claims via Motions to Dismiss and Recommended Orders, and awarded 9 claims through Agreed Orders of Dismissal and Final Orders, awarding an additional amount of \$265,421.00. With the claims under \$2,500.00, and those decided at the July Meeting, the Board decided 128 claims, dismissing a total of 52 claims, and awarding a total of 76 claims for a total amount awarded of \$300,788.63.

During the month of August, the Board of Claims received **73** negligence claims filed against the Commonwealth.

The Board rendered **188** decisions in claims *under \$2,500.00* in August 2025. Of those, **95** were dismissed and **93** were awarded for a total amount awarded of **56,190.00**. The Board did not meet in August 2025.
