KCC June 2020 Monthly Report

During the month of July, 2020, the Kentucky Claims Commission received **41** negligence claims filed against the Commonwealth.

The Claims Commission decided **29** *claims under \$2,500.00* in May, 2020. Of those, **11** were dismissed and **18** were awarded for a total amount awarded of **\$10,286.30**.

At its meeting on June 28, 2020, the Commission awarded **0** negligence more claims in the total award amount of **\$0.00** and dismissed **8** other claims. Together with the claims investigated in-house, the Commission decided **37** claims altogether while dismissing a total of **19** negligence claims and awarding a total of **18** negligence claims for a total amount awarded of **\$10,286.30** in July, 2020.
