The Board of Claims received 78 new claims during the month of June, 2009. A total of 86 new claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed one claim for being under the \$100.00 threshold.

Investigators Jackie Lynch and Wanda Luttrell decided 62 claims (under \$1,000.00) in June, 2009. Thirty one (31) claims were dismissed and 31 claims were awarded, for a total amount awarded of \$10,693.81.

At its Board meeting on June 18, 2009, the Board dismissed 21 claims and awarded six (6) claims totaling \$16,762.85. Together with the claims investigated in-house, the Board dismissed a total of 52 claims and awarded a total of 37 claims for a total amount awarded of \$27,456.66 in June, 2009.
