The Board of Claims received 53 new claims during the month of June, 2013. A total of 63 claims were set up, according to Assistant Clerk Paula Woolums. Paula also returned two (2) claims for lack of jurisdiction.

Investigator Jackie Lynch decided 26 claims under \$1,000.00 in June, 2013. Jackie reports that 12 of these claims were denied and 14 were awarded, for a total amount awarded of \$6,098.24.

At its Board meeting on June 20, 2013, the Board dismissed 13 claims and awarded eight (8) claims totaling \$11,542.16. Together with the claims investigated in-house, the Board dismissed a total of 25 claims and awarded a total of 22 claims for a total amount awarded of \$17,640.40 in June, 2013.
