Executive Director's Report:

The Board of Claims received new 59 claims during the month of October, 2008. A total of 65 new claims were set up, according to Assistant Clerk Paula Woolums. Paula also dismissed four (4) claims for being under the \$100.00 threshold. Investigators Jackie Lynch and Wanda Luttrell decided 71 claims (under \$1000.00) in October, 2008. They dismissed 45 claims and awarded 26 claims for a total amount of \$10,195.55. Together with the claims investigated in-house, the Board dismissed a total of 62 claims and awarded 32 claims for a total amount of \$25,867.57 awarded in October, 2008.
