January 2021 Monthly Report:

During the month of January, 2021, the Board of Claims received **32** negligence claims filed against the Commonwealth.

The Board rendered **32** decisions in claims *under \$2,500.00* in January, 2020. Of those, **15** were dismissed and **17** were awarded for a total amount awarded of **\$9,547.34**.

At its January, 2021 meeting, the Board awarded **3** additional negligence claims in the total award amount of **\$7,750.56** and dismissed **2** other claims. Together with the claims under \$2,500.00, the Board decided **37** claims altogether, while dismissing a total of **17** negligence claims and awarding a total of **20** negligence claims for a total amount awarded of **\$17,297.90** in January, 2021.
