February 2021 Monthly Report:

During the month of February, 2021, the Board of Claims received **45** negligence claims filed against the Commonwealth.

The Board rendered **47** decisions in claims *under \$2,500.00* in February, 2020. Of those, **37** were dismissed and **10** were awarded for a total amount awarded of **\$7,458.65**.

At its February, 2021 meeting, the Board awarded **1** additional negligence claims in the total award amount of **\$1,000.00** and dismissed **5** other claims. Together with the claims under \$2,500.00, the Board decided **53** claims altogether, while dismissing a total of **42** negligence claims and awarding a total of **11** negligence claims for a total amount awarded of **\$8,458.65** in February, 2021.
