June 2021 Monthly Report:

During the month of June, 2021, the Board of Claims received **68** negligence claims filed against the Commonwealth.

The Board rendered **53** decisions in claims *under* \$2,500.00 in June, 2021. Of those, **26** were dismissed and **27** were awarded for a total amount awarded of **\$16,160.55**

At its June, 2021, meeting, the Board awarded **1** additional negligence claim in the total award amount of **\$3,700.00** and dismissed **9** other claims. Together with the claims under \$2,500.00, the Board decided **63** claims altogether, while dismissing a total of **35** negligence claims and awarding a total of **28** negligence claims for a total amount awarded of **\$19,860.55** during the month.

July 2021 Monthly Report:

During the month of July, 2021, the Board of Claims received **57** negligence claims filed against the Commonwealth.

The Board rendered **36** decisions in claims *under* \$2,500.00 in July 2021. Of those, **19** were dismissed and **17** were awarded for a total amount awarded of **\$8,620.53**.
