August 2021 Monthly Report:

During the month of August, 2021, the Board of Claims received **51** negligence claims filed against the Commonwealth.

The Board rendered **87** decisions in claims *under \$2,500.00* in August, 2021. Of those, **32** were dismissed and **55** were awarded for a total amount awarded of **\$27,299.01**

At its August, 2021, meeting, the Board dismissed **4** claims, but no additional claims were awarded. Together with the claims under \$2,500.00, the Board decided **55** claims altogether, while dismissing a total of **36** negligence claims and awarding a total of **55** negligence claims for a total amount awarded of **\$27,299.01** during the month.
