September 2021 Monthly Report:

During the month of September, 2021, the Board of Claims received **51** negligence claims filed against the Commonwealth.

The Board rendered **23** decisions in claims *under \$2,500.00* in September, 2021. Of those, **10** were dismissed and **13** were awarded for a total amount awarded of **\$8,677.45**.

At its September, 2021, meeting, the Board dismissed **4** claims and awarded an additional **8** claims. Together with the claims under \$2,500.00, the Board decided **35** claims altogether, while dismissing a total of **14** negligence claims and awarding a total of **21** negligence claims for a total amount awarded of **\$276,677.45** during the month, with one claim (CC-18-703) being awarded the statutory maximum of \$250,000.
