Board Chair Parsons called the meeting to order at 10:00 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie.

A moment of silence was observed for the five people killed during the mass shooting at Old National Bank in Louisville, Kentucky. Executive Staff Advisor Shields advised the Board that OVC had reached out and extended their condolences and to notify our state of the Antiterrorism and Emergency Assistance Program (AEAP), which may be able to provide supplemental funding to the CVC program to help pay for claims. Executive Staff Advisor Shields stated he would reach out to LMPD within the next few days, extend condolences, and see if there was anything the Board could do to help.

Executive Staff Advisor Shields provided the statistical report to the Board and thanked Investigators White and Hubbard as well as Restitution/Collections Officer Barrie on their hard work. Executive Staff Advisor Shields also advised the Board of the passage of SB 282 and its signature by Governor Beshear on April 4, 2023. Due to the passage of SB 282, Beverly Dearborn, Budget Specialist with the PPC Office of the Secretary, advised Executive Staff Advisor Shields that a restricted allotment increase of \$400,000 was going to be requested for the remainder of FY 23 and that she wishes to meet with the Board in July to discuss the financial side of things.

Executive Staff Advisor Shields reminded the Board that their Statements of Financial Disclosure are due on April 15, 2023 and encouraged the Board to submit them if they have not done so already. Executive Staff Advisor Shields notified the Board that the JPSC grant application period has opened as of April 3, 2023 and must be submitted by May 19, 2023.

Executive Staff Advisor Shields reminded the Board that the next training on the CVC program is scheduled for April 21, 2023. Registration currently sits at 56. In terms of future events, Executive Staff Advisor Shields advised the Board that he will be representing the CVC program at an event held by LMPD on April 24, 2023 that will commemorate National Crime Victims Rights Week, will be representing the CVC program at the Kentucky Victims Assistance Academy on August 23, 2023, and will be representing the CVC program at a panel moderated by the Office of the Attorney General's Office of Victims Advocacy on August 24, 2023.

Restitution/Collections Officer Barrie advised the Board that effective April 1, 2023, mileage reimbursement is \$0.45/mile.
