Staff Attorney Bevins-Sullivan and Investigator Hubbard attended an event hosted by the Hardin County Sheriff's Office on April 11, 2025 to commemorate National Crime Victims Rights Week. The event presented a good networking opportunity for the CVCB.

Executive Staff Advisor Shields advised that the next two trainings on the CVC and SAE programs have been scheduled for April 18, 2025 and May 16, 2025 at 10:00 AM EST on Microsoft Teams. A total of thirty-five (35) individuals have registered for both trainings.
