Board Chair Parsons called the meeting to order at 09:44 AM EST and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Roberts and Sykes, Executive Director Taylor, Staff Attorneys Bevins-Sullivan and Horsman, Criminal Branch Manager Shields, Board Clerk Wilson, Investigators Kravos, Leenerts, Hubbard and Barefield, Victim Advocate Hopson, Administrative Specialist Gillis, Civil Branch Manager Barrie, and Administrative Assistant Barnett.

Board Chair Parsons motioned to adopt the March 10, 2026 minutes. Member Roberts seconded the motion. Having all in favor, the motion carried.

Executive Director Taylor gave the Executive Directors Report.

The Board undertook discussion on the proposed additional awards policy. The Board reviewed the prepared draft and Member Roberts wanted to see revisions made to it and review the revised draft at the May 12, 2026 meeting. Chair Parsons and Member Sykes agreed.

Criminal Branch Manager Shields provided his report to the Board. He discussed the Board's current backlog situation and stated the critical need for the Board to consider calling special sessions. The Board discussed and decided to call regularly scheduled special sessions going forward on the fourth Thursday of each month at 9:30 AM EST until such time that the backlog becomes more manageable or is eliminated. The Board also determined that meetings should be held in hybrid formats, precisely like those of its regular meetings. The first special session was called on May 28, 2026 at 9:30 AM EST to be held at the Board's offices located in Frankfort, Kentucky. The specific conference room is to be determined.

Criminal Branch Manager Shields also advised the Board that his upcoming trainings on the CVC and SAE programs were scheduled for May 15, 2026 and June 18, 2026.

Criminal Branch Manager Shields stated that several Criminal Branch staff members were going to events later in the month to promote the Board. Investigator Hubbard and Victim Advocate Hopson are going to Elizabethtown, Kentucky on April 24, 2026 to table at the Hardin County Sheriff's Office's annual event commemorating National Crime Victims Rights Week. Criminal Branch Manager Shields is going to be attending a sister event hosted by the Elizabethtown Police Department on April 20, 2026. Lastly, Staff Attorney Horsman will be going to Louisville, Kentucky to table yet another sister event hosted by the Louisville Metro Police Department on April 20, 2026.

Criminal Branch Manager Shields provided the Board with updates on the FFY Q2 2026 reporting requirements for Victim Advocate Hopson's position as well as the satisfaction surveys that he has been working on. The Q2 report was submitted, and accepted by OVC/OJP, two weeks ahead of schedule. The satisfaction surveys, which will measure satisfaction with not only Victim Advocate Hopson but also remaining CVC staff, are nearly complete and will be in compliance with new ADA requirements concerning accessibility.

Board Member Sykes led a discussion on survivors of stalking and how the Board may want to handle those types of claims moving forward. Board Member Sykes also advised the Board that HB 571 had passed the General Assembly and was signed into law by Governor Beshear. This legislation will be of benefit to survivors of stalking.

Civil Branch Manager Barrie advised the Board that the current mileage rate is \$0.47 per mile and will be in effect from March 2026 through June 2026.

Civil Branch Manager Barrie updated the Board on the rollout of the offender payment system. The rollout should be occurring soon and a potential demonstration of how the system will function may take place at the next meeting.

Civil Branch Manager Barrie advised the Board that new timesheets for Board Members are forthcoming. She will walk all Board Members through them.
