Board Chair Parsons called the meeting to order at 10:05 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie.

Member Roberts motioned to adopt the July 2023 minutes as proposed. Member Leenerts seconded the motion. With all voting in favor of the motion, the motion carried.

Executive Director Hardesty provided the Executive Director's report to the Board. Executive Director Hardesty mentioned to the Board that the number of claims for the Sexual Assault Examination Program has decreased and the decrease can be explained by recent changes involving Children's Advocacy Centers (CAC's). CAC's are now billing Medicaid at the time the forensic exam is being performed and patients are being enrolled in the Medicaid program. Medicaid also retroactively pays for the forensic exams, thereby not requiring the SAEP to pay. Fewer claims are being received as a result.

All Board Members and staff of the Crime Victims Compensation Board have completed their required trauma-informed care training for 2023, except for Member Roberts. A training date for Member Roberts is being scheduled. Executive Director Hardesty will let Member Roberts know once the date has been set.

The CVC working group's next meeting will be on 08/10/2023 at 11:30 AM.

There has been no word yet on the VA grant. However, a response should be received by 09/01/2023. Executive Director Hardesty will update the Board once he hears back.

Executive Staff Advisor Shields gave his report to the Board. The next trainings for the program have been scheduled for 08/18/2023 and 09/15/2023. There have been ninety (90) registrants for the 08/18/2023 training and 38 registrants for the 09/15/2023 training. Executive Staff Advisor Shields will also be speaking about CVC with the Highland Heights Police Department on 08/15/2023, will be heading to Lake Barkley State Park on 08/23/2023 to speak about CVC with the Kentucky Victims Assistance Academy, and will be heading to Lexington on 08/24/2023 to take part in a prosecutor-based victim advocate panel being moderated by the Office of the Attorney General.

Restitution/Collections Officer Barrie advised the Board that both she and Investigator White will be attending the national VOCA conference in Chicago during the week of 08/14/2023.
