98 total claims were decided by the Board for July 2024.

Board Chair Parsons called the meeting to order at 10:05 AM and conducted roll call.

The following were in attendance at the meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Hubbard and White, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Member Roberts motioned to accept the July 2024 minutes as drafted. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty gave his Executive Director's report to the Board and introduced Victim Advocate Hopson. Executive Director Hardesty also advised the Board that Member Roberts will be reappointed to serve.

Executive Director Hardesty, Executive Staff Advisor Shields, Investigator Hubbard, and Restitution/Collections Officer Barrie attended the national VOCA conference in New Orleans, LA from August 4, 2024 through August 8, 2024. Executive Director Hardesty advised that he and Executive Staff Advisor Shields may conduct a webinar regarding how state funding was secured to expand the CVC program in the near future.

A request to hire additional staff has been sent up the chain of command and a decision is forthcoming.

The Board discussed whether to apply the new award caps and expense categories from SB 319 to claims that have been filed but not adjudicated or to only apply those to claims that were filed on or after the July 15, 2024 effective date. After discussion, the Board decided to apply the new award caps and expense categories to all claims that have been filed but have not been adjudicated as of the July 15, 2024 effective date.

Executive Staff Advisor Shields provided his Executive Staff Advisor report to the Board. The next training on the CVC and SAE programs has been scheduled for August 16, 2024. Registration for the training currently sits at 35.

The Board discussed how to handle offender debts when the Department of Revenue is no longer collectiong on those debts that are more than ten (10) years old. The Board decided to take a case-by-case approach as to whether to continue to try to collect on those debts given the unique circumstances at play in each situation.
