Board Chair Parsons called the meeting to order at 10:15 a.m. and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Roberts and Sykes, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Clerk Wilson, Investigators Hubbard, Kravos, Leenerts, Lisby, and Barefield, Administrative Specialist Gaines and Sexual Assault Exam Administrator Gillis, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Board Member Roberts motioned to adopt the July 2025 minutes. Member Sykes seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty gave his directors report to the board. Executive Director Hardesty advised that he will resigning as Executive Director effective August 16, 2025. Executive Director Hardesty's replacement will be Allyson Taylor who is the outgoing Commissioner of Alcoholic Beverage Control. Taylor is a former procecurtor and has experience working with crimes involving children.

Final touches are being made with the renewing of Victim Advocate Hopson's grant. The hope is to continue to have Victim Advocate Hopson's employment occur through the grant. However, if that were to fall through, the agency should have sufficient monies to hire Victim Advocate Hopson full time.

Pursuant to House Bill 215, the SART Advisory Committee has to do a training video on Sexual Assault Matters. Executive Staff Advisor Shields will be working with the Kentucky Hospital Association to get the training video recorded.

The Board discussed joint and several liability by offenders on awards issued by the Board and whether the Board wants to allow for incremental payments to be made by offenders on debts they owe to the Commonwealth. The Board wants to continue with established precedent and allow offenders to pay a proportion of the total debt owed but to do so in full rather than allowing for incremental payments.
