According to IT, the issues arise when a recipient tries to view PDF's on their tablets or cell phones. The Board was asked to view any materials sent to them on their laptops, PC, or Mac as opposed to their tablets or cell phones to avoid such an issue in the future.

Executive Director Hardesty also advised the Board that the Public Protection Cabinet has been tasked with administering the recently created Team Western Kentucky Tornado Relief Fund to assist those affected by the severe weather that struck Western Kentucky on December 10, 2021 and into December 11, 2021.

The Board set its next meeting for January 11, 2022 at 10 AM to be held at 500 Mero St., Frankfort, KY 40601 with a Zoom option for the public.
