111 total claims were decided by the Board for November 2024.

Board Chair Parsons called the meeting to order at 9:49 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigator Hubbard, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Member Roberts motioned to accept the November 2024 regular meeting minutes. Member Leenerts seconded the motion. Having all in favor, the motion carried. In a second motion, Member Roberts motioned to accept the November 2024 special meeting minutes. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty gave his Executive Director's report to the Board. The agency is looking to hire six (6) new employees for the CVC/SAE program. Three (3) of these positions are currently being interviewed for and the other three (3) will be posted to the register very soon.

The proposed administrative regulations will be filed with the Legislative Research Commission on December 13, 2024 provided that the Board approves them later during the meeting. The administrative regulations will amend the policies and procedures of the Board due to the requirements set forth by SB 319. Once the regulations are filed, it is expected that the promulgation process will take approximately eight (8) to nine (9) months. Member Roberts motioned to accept the proposed administrative regulations as drafted. Member Leenerts seconded the motion. Having all in favor, the motion carried.

The Board discussed the filing of multiple emergency requests per claim and instructed that a policy be drafted by Staff Attorneys Bevins-Sullivan and Horsman for review by the Board at the January 2025 meeting.

Executive Staff Advisor Shields gave his report to the Board. The next trainings for the CVC/SAE programs have been scheduled for January 17, 2025, February 21, 2025, and March 21, 2025. Five (5) individuals with the Louisville Metro Police Department's Victims Services Unit have already indicated interest in attending a training. Executive Staff Advisor Shields will draft a training solicitation memorandum for submission to the Justice and Public Safety Cabinet soon.
