Board Chair Parsons called the meeting to order at 09:18 a.m. and conducted roll call.

Claimant [REDACTED] also attended and provided testimony to the Board.

The Board discussed adopting a policy to delegate authority to the Executive Director to decide claims where claimants have not perfected them or have asked to have their claims withdrawn. Staff Attorney Bevins-Sullivan researched the topic and her research determined that because these types of claims are not decided on the merits, the board chair can delegate authority to the Executive Director to draft dismissal orders.

The Board also discussed creating a policy regarding situations in which claimants received emergency assistance but their claims were ultimately denied. The policy outlined steps that will need to be taken when collection activities have to be undertaken by legal staff. The Board discussed this policy during executive session and made amendments to the proposed policy. After exiting executive session and returning to open session, Member Roberts motioned to adopt the policy with amendments discussed in executive session. Member Sykes seconded the motion. Having all in favor the motion carried.

Board Clerk Wilson advised that there are 300 claims waiting to be decided by the board.
