Executive Director Hardesty provided his statistical report to the Board and discussed a draft bill from the LRC that arose from the CVC working group that Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, and SAEP Coordinator Greene were part of last year. Executive Director Hardesty will track the bill and will keep the Board apprised of any developments. Executive Director Hardesty also brought to the Board's attention that Member Leenerts' term is set to expire in July 2023. Member Leenerts expressed a desire to be reappointed. Executive Director Hardesty will keep Member Leenerts apprised of any developments concerning her possible reappointment.

Staff Attorney Bevins-Sullivan discussed her recent revisions to the emotional support animal policy and her memo on an expanded lost earnings policy. The emotional support animal policy was suitable for discussion and the lost earnings policy memo was explanatory in nature and more work needs to be done before a draft policy is put before the Board.

After discussing the draft emotional support animal policy, Board Chair Parsons motioned to officially adopt the policy as drafted. Member Leenerts seconded the motion. With all voting in favor of the motion, the motion carried. The adopted policy will be conspicuously published on the Board's website.

After discussing specifics on the lost earnings policy memo, the Board stated that they wished to see and review a draft policy at the March 2023 meeting.
