65 total claims were decided by the Board for January 2025.

Board Chair Parsons called the meeting to order at approximately 10:35 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Member Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Hubbard, Kravos, and Leenerts, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Member Roberts motioned to accept the January 2025 minutes. Board Chair Parsons seconded the motion. With a majority of the Board concurring, the motion carried.

Executive Director Hardesty presented his Executive Director's report to the Board. After presenting his Executive Director's Report, Executive Director Hardesty introduced the Board's two new investigators, Amy Leenerts and Levi Kravos. Investigator Kravos then introduced himself to the Board.

Executive Director Hardesty advised the Board that interviews are currently being conducted for two more investigator positions with the hope being that hiring decisions will be made within the next

couple of months. Additionally, two more positions have formally been created. One of these two positions will be split between helping with the Board of Claims and helping Restitution/Collections Officer Barrie with her collection activities and the other will assume the Clerkship of the Board, which will allow Executive Staff Advisor Shields to focus more on his supervisory responsibilities along with his other roles in the agency.

Executive Director Hardesty advised the Board that Brandy Gillis will begin working with Sexual Assault Exam Program Coordinator Greene on March 1, 2025.

All applicable confirmations for the Board are currently being sought.

Executive Director Hardesty advised the Board that the recent desk review conducted by the Justice and Public Safety Cabinet's Grants Management Division regarding Victim Advocate Hopson's grant went well. There were two recommendations for improvement: (1) more detailed records from Victim Advocate Hopson regarding his daily activities and (2) per grant conditions, a grievance and non-discrimination policy for victims that interact with the program is required. The Board reviewed the draft policy prepared by Executive Director Hardesty. After review, Board Chair Parsons motioned to adopt the grievance and non-discrimination policy and grievance form. Member Roberts seconded the motion. Having a majority of the Board in favor, the motion carried.

Executive Staff Advisor Shields advised the Board that the next two trainings for the CVC/SAE programs have been scheduled for February 21, 2025 and March 21, 2025. Executive Staff Advisor Shields also advised the Board that both Victim Advocate Hopson and himself had been working with the Cabinet's Office of Information Technology (OIT) to create a report for Victim Advocate Hopson's statistics that are required to be reported quarterly. That report has been created and is functioning as intended. Lastly, Executive Staff Advisor Shields advised that he is working with OIT on satisfying the last remaining IT need for SB 319: the online portal. The portal must be live by August 1, 2025 and it should be completed well ahead of schedule.

Restitution/Officer Barrie advised the Board that she is looking into getting functionality created to allow for offenders to pay their debts online. That should help with increasing revenues while simultaneously reducing Restitution/Collection Officer Barrie's workload.

Staff Attorney Bevins-Sullivan advised the Board that the first public comment on the Board's proposed administrative regulations was received. She will reach out to the sender of the comment to discuss.
