Board Chair Parsons called the meeting to order at 10:02 AM and conducted roll call.

The following were in attendance at the meeting: Board Chair Parsons, Member Leenerts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie. Member Roberts was absent.

Board Chair Parsons motioned to accept the December 2022 meeting minutes as drafted. Member Leenerts seconded the motion. With both voting members being in agreement, the motion carried.

Executive Director Hardesty gave his statistical report to the Board and reiterated to the Board that the Department of Medicaid had recently increased the CAC reimbursement rate to \$894.00 with a permanent rate being established at a later date. Executive Director Hardesty advised the Board that the agency is still waiting on a copy of the draft bill arising from the CVC working group. Executive Director Hardesty also advised the Board that Restitution/Collections Officer Barrie collected a total of \$354,223.23 in restitution and donations for calendar year 2022, which is a testament to the hard work that she has put in.

Executive Staff Advisor Shields presented his report to the Board and highlighted key statistics for calendar year 2022. Executive Staff Advisor Shields also advised the Board that the next trainings on the CVC program have been scheduled for February 17, 2023, March 17, 2023, and April 21, 2023.

Staff Attorney Bevins-Sullivan advised the Board on changes she had made to her draft policy concerning emotional support animals. The Board discussed those changes and tabled issuing a decision on whether to adopt the policy until Member Roberts has had the opportunity to review and provide his input. A final version of the policy will be provided to the Board for review at the February meeting.

In regard to adopting a policy for lost earnings similar to that of the bereavement policy for homicide cases, Staff Attorney Bevins-Sullivan advised the Board that she would like to conduct further research before drafting a policy for review by the Board. Staff Attorney Bevins-Sullivan hopes to have either a draft policy or a memorandum ready for the Board to review at the February meeting.
