Executive Director Hardesty advised the Board that a candidate for the vacant Staff Attorney III position has been identified. The hope is that the candidate will accept and will be hired soon.

Executive Director Hardesty advised the Board that the Crime Victims Compensation bill will be finalized and filed soon.

Executive Director Hardesty advised the Board that their Statements of Financial Disclosure will need to be completed and submitted by 4/15.

Executive Staff Advisor Shields gave his Executive Staff Advisor's report to the Board. The next trainings on the CVC and SAE programs have been scheduled for 1/19 (16 registrants), 2/16 (8 registrants), and 3/15 (5 registrants). Additionally, Executive Staff Advisor Shields advised the Board that he conducted a training at Fort Knox to approximately 60 personnel with the Fort Knox Sexual Harassment/Assault Response and Prevention program on the availability of crime victims compensation.
