127 total claims were decided by the Board for December 2024.

Board Chair Parsons called the meeting to order at 10:18 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigator Hubbard, Victim Advocate Hopson, and Restitution/Collections Officer Barrie.

Board Chair Parsons motioned to adopt the December 2024 minutes. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty provided his Executive Director's report to the Board, advised that soft offers had been accepted by the chosen two (2) investigator candidates, and expects that Personnel will approve those. The two (2) new investigators will start on February 1, 2025. The other two (2) investigator positions should be posted to the employment register shortly.

Executive Director Hardesty advised the Board that work is currently being done on securing an additional staff member to assist with the Sexual Assault Examination Program.

Executive Staff Advisor Shields advised the Board that 592 claims had been filed in calendar year 2024, which was roughly a 62% increase over 2023's figures. Executive Staff Advisor Shields also advised the Board of the next training dates (January 17, 2025, February 21, 2025, and March 21, 2025).

The Board discussed the proposed policy regarding allowing Claimants more than one opportunity to file emergency award requests. Claimants may only submit one (1) emergency award request. If the request is denied, the order denying the request cannot be appealed. Multiple award requests shall only be considered by the Board in the most extraordinary circumstances, subject to the Board's discretion. After discussion, Member Roberts motioned to accept the policy. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Staff Attorney Horsman updated the Board on the Department of Revenue's not pursuing offender debts after ten (10) years of collection activity. After discussion, the Board agreed to continue pursuing offenders after the Department of Revenue's ten (10) year collection activities ceases.
