Staff Attorney Bevins-Sullivan will also begin working on preparing draft policies on emotional support animals and bereavement for the Board to review and potential adoption at the August meeting.

Executive Staff Advisor Shields gave his report to the Board. ESA Shields and Staff Attorney Bevins-Sullivan conducted training on the CVC program with representatives from Safe Passage Kentucky, an organization that works with child survivors of human trafficking. ESA Shields may also be attending the KASAP annual conference in Lexington from November 30 through December 2, 2022 and advised the Board that the next training on the CVC program is scheduled for September 16, 2022 at 10 AM via Zoom.
