74 total claims were decided by the Board for June 2024.

Board Chair Parsons called the meeting to order at 10:16 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Hubbard and White, and Restitution/Collections Officer Barrie. Claimant DT attended as a guest.

Member Roberts motioned to accept the June 2024 minutes. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty gave the Executive Director's report to the Board. Executive Director Hardesty advised the Board that a victim advocate has been hired and his first day will be July 16, 2024. Additionally, an official request to hire more staff has been made. However, it is unknown how many new staff members will be approved. Executive Director Hardesty hopes that new staff will be hired within the next several months and he will keep the Board apprised.

Executive Director Hardesty reminded the Board that SB 319 goes into effect on July 15, 2024. Many changes have been made to the calim form, database, and administrative regulations. Everything is on track to be ready to go for July 15, 2024.

Executive Staff Advisor Shields gave his report to the Board. The next two trainings on the CVC and SAE programs are scheduled for July 19, 2024 and August 16, 2024. Registration for July 19th currently sits at 34 and registration for August 16th currently sits at 26. A total of 37 people attended the training on June 21, 2024.

Executive Staff Advisor Shields also advised the Board that he is working on user acceptance testing (UAT) for the online claim form and database this week to ensure a smooth transition pre and post-SB 319. Additionally, Executive Staff Advisor Shields advised the Board that claim filings continue to increase. A total of 18 claims have been filed within the first week of this month.

Executive Staff Advisor Shields has been asked to speak at the Kentucky Victims Assistance Academy (KVAA) on August 22, 2024 about CVC. In addition, Executive Staff Advisor Shields has been asked by leadership at Norton Healthcare to conduct a specialized training on the CVC and SAE programs. A date for this presentation is currently awaiting scheduling.

Restitution/Collections Officer Barrie advised the Board that the mileage reimbursement rate for July 1, 2024 through September 30, 2024 is \$0.45 per mile.
