If Victim Advocate Hopson can not be retained through the grant, then a push will be made to retain him by using agency funds.

The 120 day investigator time-frame is now in effect. An annual report outlining the number and percentage of cases in which this time-frame is not adhered to will be submitted to the Governor's Office and to the Legislative Research Commision for referral to the Interim Joint Committee on Judiciary going forward.

Given the large size of dockets over the preceeding couple of months combined with anticpated large dockets over the next few months, the board discussed whether to meet one day per month and hold a longer meeting or call special sessions. After discussion, the board decided to continue with the current meeting schedule.
