127 total claims were decided by the Board for May, 2023.

Board Chair Parsons called this month's meeting to order at approximately 10:00 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Investigators Hubbard and White, and Restitution/Collections Officer Barrie. Absent was Executive Staff Advisor Shields.

Member Roberts motioned to adopt the May 2023 minutes as proposed. Member Leenerts seconded the motion. With all voting in favor of the motion, the motion carried.

Executive Director Hardesty provided his statistical report to the Board and mentioned that the victim advocate grant application had been submitted. He is hopeful that a decision will be made in either June or July 2023. The victim advocate would help decrease investigators' caseloads by helping victims with filling out forms and getting needed information for claims, which would allow the investigators more time to focus on conducting their investigations. The victim advocate would also help with establishing and maintaining connections with other organizations that work with survivors. Member Roberts motioned to approve the victim advocate position and application for the VOCA assistance grant. Member Leenerts seconded the motion. With all voting in favor of the motion, the motion carried.

Executive Director Hardesty also advised the Board that the CVC working group is reconvening with the goal of broadening both what the CVC and SAE programs can do. To this end, Senate Bill 283, as currently proposed, would bring sweeping changes to both programs and would require substantially more staff. Executive Director Hardesty will keep the Board updated on the activities of the working group.

Executive Director Hardesty also mentioned that Member Leenerts' term is set to expire at the end of this month. Member Leenerts can continue to serve in her position until she is either reappointed or until a replacement is appointed. Her reappointment is currently on the Governor's Office's radar.

Staff Attorney Bevins-Sullivan provided Executive Staff Advisor Shields' report to the Board in his stead.

Restitution/Collections Officer Barrie reminded the Board that she needed their travel vouchers by June 23, 2023 and stated that mileage is still being reimbursed at a rate of \$0.45/mile.
