Board Chair Parsons called the meeting to order at 10:03 AM and conducted roll call.

The following individuals were in attendance at this month's meeting in person: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, Restitution/Collections Officer Barrie, and Claims Investigator Hubbard. Staff Attorney Lile was in attendance by Zoom.

Member Roberts motioned to accept the February 8, 2022 meeting minutes as presented to the Board. Member Leenerts seconded the motion. There were no abstentions or nays. The motion unanimously carried. The February 8, 2022 meeting minutes were officially adopted.

Executive Director Hardesty provided his report to the Board.

Executive Director Hardesty advised the Board that Kristen White has been hired to be the CVCB's new claims investigator and will begin on March 16, 2022. Ms. White will predominantly work with CVCB claims but will also assist with the Board of Claims and the CVCB's Sexual Assault Examination Program on a limited basis.

Executive Director Hardesty thanked Restitution/Collections Officer Barrie on her continued hard work with getting restitution and collections figures to increase.

Governor Beshear has announced that masks are now optional in Execuitve Branch office buildings but certainly can be worn if an individual feels more comfortable doing so.

Ttwo joint resolutions have been filed in regards to the confirmations of two of OCA's Board Members (Member Leenerts and Board of Tax Appeals "BTA" Member Tony Colyer). No votes have been taken yet but the Board will be kept apprised of any developments.

The Executive Branch Ethics Commission is currently hiring for an Executive Director and as a result the Executive Branch ethics training has been stymied until a Director has been appointed. Executive Director Hardesty will keep the Board apprised on when the trainings resume.

Board of Claims Clerk Katie Dean has planned staff and Board Clerk trainings on the Citrix virtual desktop application. Clerk Dean and Executive Staff Advisor Shields will conduct the training with the CVCB soon.

A recent court case concerning open records matters was recently decided by the Franklin Circuit Court. In that case, the Court held that the use of personal emails for official state business would leave their personal email addresses open to potential open records requests.

The Board engaged in a policy discussion on Sexual Assault Examination Program claims. SAEP Coordinator Greene spends a great deal of time corresponding with Claimants to encourage claim perfection. In order to increase claims efficiency, the Board stated that SAEP Coordinator Greene should make one attempt to encourage claim perfection and allow them a thirty-day period after initial submission to perfect their claim. If the claim is not perfected within that thirty-day period, claims should be placed on the next docket for claim determinations.

Executive Staff Advisor Shields advised that his training with the Statewide Human Trafficking Task Force went very well. In addition, ESA Shields advised the Board that he has been asked by the London Rotary Club to come speak about the CVC program and has received approval from the PPC Office of Communications and Public Outreach. The next trainings on the CVC program with the public have been scheduled for March 18, 2022 and April 14, 2022.
