Board Chair Parsons called the meeting to order at 10:07 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Member Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigators Kravos and Leenerts, Victim Advocate Hopson, Restitution/Collections Officer Barrie, and SAEP Administrator Gillis. Claimant CG also joined as a guest.

Member Roberts motioned to accept the February 18, 2025 minutes. Board Chair Parsons seconded the motion. Having a majority of the Board in favor, the motion carried.

Board Chair Parsons nominated Member Roberts to serve as Vice Chair of the Crime Victims Compensation Board. Member Roberts accepted the nomination and seconded the motion. Having a majority of the Board in favor, the motion carried.

Executive Director Hardesty provided his Executive Director's report to the Board and advised that

Member Roberts' confirmation is still proceeding through the Senate. A resolution to confirm him has been filed.

The filed administrative regulations continue to move through the promulgation process. One comment has been filed thus far and concerns crime scene cleanup certification.

The Board met Brandy Gillis, the new SAEP Administrator. SAEP Administrator Gillis has hit the ground running and should be an asset to the agency.

An offer was made to another candidate for CVC claims investigator and was accepted. The candidate will begin work on April 1, 2025. Job postings will be posted soon to hire one more CVC claims investigator, one replacement Board Clerk, and one person to help Restitution/Collections Officer Barrie with the restitution/collections program.

Member Roberts motioned to enter closed session, pursuant to KRS 61.180(1)(c) and (j) and KRS 61.818 at approximately 10:21 AM to discuss CV-2023-00337. Board Chair Parsons seconded the motion.
