Board Chair Parsons called the meeting to order at 10:02 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Lile, Executive Staff Advisor Shields, Restitution/Collections Officer Barrie, and Investigators Hubbard and White.

Board Chair Parsons motioned to adopt the April 2022 meeting minutes as drafted. Member Leenerts seconded the motion. There were no abstentions or nays. The motion carried.

Executive Director Hardesty provided his monthly report to the Board and praised Restitution/Collections Officer Barrie for her hard work on the agency's restitution/collections activities. All Board Members for the CVCB were confirmed by the General Assembly on the last date of the session. One new member was appointed to the Board of Claims and Governor Beshear will appoint the remaining member in the not too distant future.

The Executive Branch Ethics Commission is still without an Executive Director and as a result, the Board's ethics training remains in limbo.

Executive Director Hardesty solicited feedback from the Board on the Citrix virtual desktop application. Any issues that the Board may be experiencing can be forwarded to the Board of Claims Clerk Katie Dean.

The Board engaged in policy discussions on emotional support animals and automatically granting lost earnings to Claimants for bereavement in homicide cases. After discussion, the Board determined that further research needs to be conducted and presented before policies are officially decided upon.

Executive Director Hardesty advised the Board that the General Assembly had passed Senate Bill 378 and was signed into law by Governor Beshear, which requires the Board and all staff to undergo trauma-informed training. Each Board and staff member will be required to undergo six hours of training within thirty days of the law's effective date. Training sources are currently being examined and Executive Director Hardesty will keep the Board updated.

Executive Staff Advisor Shields presented his report to the Board. The training he conducted with the London Rotary Club went very well. The audience was engaged and asked good questions. ESA Shields and other staff will be conducting trainings on the crime victims compensation program on May 20 and June 17, 2022.

Restitution/Collections Officer Barrie advised the Board that she is currently in the closeout process for FY22. Restitution/collections activities are going well and lots of feedback is being received.
