Board Chair Parsons called the meeting to order at 10:06 AM and conducted roll call.

The following individuals were in attendance at this month's meeting: Board Chair Parsons, Member Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigator Hubbard, Investigator Kravos, Investigator Lisby, Investigator Leenerts, Victim Advocate Hopson, Restitution/Collections Officer Barrie, and Sexual Assault Examination Program Administrator Gillis.

Board Chair Parsons motioned to adopt the April 2025 minutes. Member Roberts seconded the motion. Having a majority of the Board in favor, the motion carried.

Executive Director Hardesty provided his Executive Director's report to the Board.

Executive Director Hardesty advised the Board that offers either have been made or are going to be made to the last three open positions with OCA. The candidate for one of those positions (CVC claims investigator) has accepted their offer and will start on June 9, 2025. Amber Craig has accepted a full-time offer and will begin on May 16, 2025. Ms. Craig will split her time between helping Restitution/Collections Officer Barrie with collections and the Board of Claims. Finally, approval is still being sought to make an offer for the last open position (CVC Clerk). However, the anticipated start date for the CVC Clerk position is June 1, 2025.

Executive Director Hardesty and Staff Attorney Bevins-Sullivan are going to be testifying before the Administrative Regulations Review Subcommittee (ARRS) later today. This is the last big step in getting the new regulations adopted. Assuming that no deficiencies are noted, the new regulations are anticipated to go into effect in October 2025.

The appointment of the third CVCB Member is still in process. A recommendation has been sent up and is currently being reviewed by the Governor's Office.

Staff are currently working on several IT projects for the CVCB.

Executive Staff Advisor Shields advised the Board that the upcoming training on May 16, 2025 currently has forty-seven (47) registrants.
