Board Chair Parsons called the meeting to order at 09:31 AM EST and conducted roll call.

Board Chair Parsons motioned to adopt the April 14, 2026 minutes. Member Roberts seconded the motion. Having all in favor, the motion carried.

Executive Director Taylor gave the Executive Directors Report.

Executive Director Taylor advised the Board that Criminal Branch Manager Shields applied for a renewal grant for Victim Advocate Hopson's position, which has been approved.

Executive Director Taylor advised the Board that good progress was being made on reducing the

Executive Director Taylor advised the Board that good progress was being made on reducing the backlog and thanked the Board for being willing to call special sessions to address it.

Criminal Branch Manager Shields provided statistical information to support Executive Director Taylor's statement. By the end of June, 2026, the Board should adjudicate close to 207 claims in just a couple of months. Additionally, 154 claims are currently awaiting R/O generation or are otherwise ready to appear before the Board.

The Board reviewed the draft additional awards policy with amendments requested from last month's meeting. After review, Board Chair Parsons motioned to adopt the policy. Member Sykes seconded the motion. Having all in favor, the motion carried. The Board officially delegated its authority to issuing additional awards to the Executive Director.

Staff Attorney Bevins-Sullivan advised the Board that today would be her last meeting with the Crime Victims Compensation Board. She has accepted a position as General Counsel with the Kentucky Higher Education Student Loan Corporation (KHESLC).
