Executive Staff Advisor Shields gave the Executive Director's report to the Board on behalf of Executive Director Hardesty.

Executive Staff Advisor Shields advised the Board that three claims will be coming before them on the December docket in which fraud is suspected. In addition, Executive Staff Advisor Shields advised that Executive Branch offices will be closed on December 12, 2023 for Inauguration Day. Staff Attorney Bevins-Sullivan also advised that several staff will be conducting an informal interview with a potential candidate for the Victim Advocate position next week.

Restitution/Collections Officer Barrie advised the Board that OCA is still looking for another staff attorney to replace former Staff Attorney Lile.
