114 total claims were decided by the Board for October 2024.

Board Chair Parsons called the meeting to order at 10:06 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Investigator White, and Restitution/Collections Officer Barrie. Investigator Hubbard and Victim Advocate Hopson were absent. Claimant K.M. attended as a guest.

Member Roberts motioned to accept the November 2024 minutes as drafted. Member Leenerts seconded the motion. Having all in favor, the motion carried.

Executive Director Hardesty gave his Executive Director's report to the Board. The draft of the administrative regulations have been sent up the chain of command for approval. The goal is to file the regulations before the December 13, 2024 deadline. A special session will need to be called for the Board to officially approve them.

Investigator White will be leaving OCA with her last day being November 15, 2024. A special lunch will be held on November 15, 2024 and the Board has been invited to attend. With Investigator White's upcoming departure, her position will be posted to the employment register as soon as possible.

A review of the applications for the first three staff members is currently underway. The goal is to hire them within the next month or two.

The annual trauma informed care training has been scheduled for December 10, 2024 at 1:30 PM. Given that this date is also the same date as the December 2024 board meeting, the Board elected to move the meeting time to 9:30 AM from its normal time of 10:00 AM.
