The Crime Victims Compensation Board called this special session at its regularly scheduled meeting on October 14, 2025.

At its regularly scheduled meeting held on November 13, 2025, the Crime Victims Compensation Board:

Awarded 17 CVC claims for a total award amount of \$182,400.25  
Denied 15 CVC claims  
Ordered 3 CVC claims withdrawn

Awarded 64 SAEP claims for a total award amount of \$18,039.75  
Denied 10 SAEP claims

115 total claims were decided by the Board at its regularly scheduled meeting on November 13, 2025.

Staff Attorney Bevins-Sullivan called the meeting to order at 10:03 AM and conducted roll call.

The following were in attendance at the meeting: Members Roberts and Sykes, Executive Director Taylor, Staff Attorneys Bevins-Sullivan and Horsman, Executive Staff Advisor Shields, Clerk Wilson, Investigators Leenerts, Lisby, Hubbard, and Barefield, Victim Advocate Hopson, Restitution/Collections Officer Barrie, and Administrative Specialist Gaines. Claimant W.M. also joined and addressed the Board. Chair Parsons was absent.

The Board extended its condolences to Board Chair Parsons on the death of her husband earlier this month.

Executive Director Taylor gave her Executive Director's report to the Board. Executive Director Taylor also advised the Board that work is currently being done on the agency's statutory reporting requirements to the General Assembly and the Governor's Office.

Executive Staff Advisor Shields gave his report to the Board. The next training for the CVC and SAE programs is scheduled for November 21, 2025 and fifty-seven (57) people have registered. Executive Staff Advisor Shields also encouraged the Board to consider calling special sessions next year beginning in January to address a backlog of claims that has developed and which are awaiting adjudication by the Board. Approximately 265 claims have been investigated and are awaiting adjudication, which is an increase from approximately 235 in October.
