Board Chair Parsons called the meeting to order at 10:10 AM and conducted roll call.

The following were in attendance at this month's meeting: Board Chair Parsons, Members Leenerts and Roberts, Executive Director Hardesty, Staff Attorney Bevins-Sullivan, Executive Staff Advisor Shields, and Investigators Hubbard and White.

Board Chair Parsons motioned to accept the September 2023 board meeting minutes. Member Leenerts seconded the motion. Member Roberts was not present. With having a majority vote, the motion carried.

Executive Director Hardesty gave his Executive Director's report to the Board.

Executive Director Hardesty advised the Board that the CVC bill will be heard by the Interim Joint Committee on the Judiciary at its December meeting. This bill may provide additional funding for the program and contain mechanisms to safeguard against shortfalls in general revenue funds.

The federal VOCA fund will probably be decreasing in the near future, which will require state programs to provide more funds to operate their CVC programs.

Member Roberts' trauma informed training is scheduled on 10/23/2023 from 10:00 AM through 1:00 PM.

The Board is still working on getting its victim advocate hired.

A new legal intern for OCA will begin work on 10/16/2023.

Executive Director Hardesty discussed KRS 49.340 as it relates to Board Members reviewing claims individually and issuing Recommended Orders. Executive Director Hardesty reminded the Board that if they cannot make a recommendation based on the information submitted to them, they are required to hold a formal hearing conforming to KRS 13B requirements.
